WAIVER & RELEASE AGREEMENT

Please read carefully before signing

This is a release of liability and waiver of certain legal rights

In consideration for my being permitted to be a guest at the premises and participate in the activities of Oak Alley Farms and/or, Robert Brace & Sons, Inc., and/or Deer Head Inn referred to collectively in this agreement as "the Farm", I agree to the following Waiver & Release.

I acknowledge that fishing and/or hunting has inherent risks, hazards, and dangers (the "Risks") to which I may be exposed during my stay at the Farms and with respect to any activities I may participate in while at the Farm.

I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession.
2. The risk of injury from ammunition and shot from other guns.
3. Wading in rugged country, including encounters with wildlife, animals, and insects.
4. Inclement weather conditions, without limitation.
5. The risk of injury from the use of tree stands.
6. The hazards & risks inherent of being on or about these locations.
7. The risk of personal injury, death and damage to personal property which may result from fishing in or round, wading or fording rivers & streams.
8. Domestic and wild animals.
9. Travel either on foot or in a vehicle in unfamiliar terrain, or over fences, other structures, artificial and natural obstructions and unimproved roads.

I understand the risks, hazards, and dangers of hunting & fishing and have had the opportunity to discuss them with the Farm's Management and Staff. I understand that these activities may require good physical conditioning and a degree of skill and knowledge. I believe I have that good physical conditioning and the degree of skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities. My participation in this activity is purely voluntary. No one is forcing me to participate and I elect to participate in spite of the risks. **I AM VOLUNTARILY USING THE SERVICES OF OAK ALLEY FARMS WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS, OR DEATH.**

Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY AND HOLD HARMLESS OAK ALLEY FARMS (ROBERT BRACE & SONS, INC), their directors, officers, agents, employees, and volunteers from and against any and all claims, actions, causes of action, liabilities, suits, expenses (including reasonable attorneys' fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to, NEGLIGENCE of any kind or nature, whether foreseen or unforeseen, arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or my property as a result of my engaging in these activities or the use of these services, animals, or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of the FARM or from some other cause. I, for myself, my heirs, my successors, executors, and subrogates, further agree not to sue OAK ALLEY FARMS and its affiliates as a result of any injury, paralysis, or death suffered in connection with my use and participation in the activities of hunting and/or fishing.

I hereby hold harmless and release and forever discharge Oak Alley Farms and its affiliates from all claims, demands, and causes of action which I, my heirs, representatives, executors, administrators, or any other persons acting on my behalf or on behalf of my estate have or may have by reason of this authorization.

I HAVE CAREFULLY READ, CLEARLY UNDERSTAND AND VOLUNTERILY SIGN THIS WAIVER and RELEASE AGREEMENT.
